A. <u>EMERGENCY ROAD CLOSURE</u>: Motion to ratify the road closure on West Philadelphia Street between Oxford Street and Berwick Street that occurred on March 2, 2021, from 2 p.m. to 7 p.m. for an emergency gas line repair by Columbia Gas.

B. <u>FIREMAN'S RELIEF ASSOCIATION AGREEMENT</u>: Motion to approve, revise, table or deny entering into an agreement with the Fireman's Relief Association of West Manchester Township for Relief to contribute \$23,235.75 towards the purchase of the new Utility for the Fire Department. The total cost of the vehicle is \$70,931.50. Also, that if the vehicle is ever sold that a prorated share of 32.75% will go back to relief. This is the same agreement entered into in the past with all the fire department vehicles that relief contributes funds towards.
