Contract award and kick off support for the sewer rehabilitation efforts from the Gems Area to Derry St and the Hayward Area to Derry St.

Requesting and examining sewer inspection data gathered in April of 2024 from the West King Street Interceptor and related sewers by USG during an unusually high flow period.

Correspondence regarding CSL's data analysis.

Work on layout maps/profiles and other engineering design/specification support for the sewer deepening/extension up Taxville Road to Baker Road and south of Taxville in/along Baker.

Support for Public Works (PW) Director and staff on installation of new pumps (shelf spares), check valve repairs, and rotation change for one pump at the West King Street Pumps Station.

Communication with PW Director about alternative for odor control at the West Market Street Pump Station and sewer/pump station improvements.

Finishing and submitting the 2024 Waste Load Management Report (a.k.a. Chapter 94 Report) for the Shiloh and Lincolnway sewer areas, finishing the corrective action plan update letter for attachment to the report Shiloh, and related correspondences.

Communication regarding 537 Plan update for Bair Station.

Advancing drawings for the final design for the Warwick Phase 1 Stormwater Project.

Communication with Township staff regarding completion of a buried infiltration structure in Sunset Park and improvements to the original basin and outlet control structure.

Estimating the cost of an infiltration basin and stormwater conveyance improvements in the Brenda Rd and Potomac Ave area to relieve ponding and overflowing road gutters. Estimating a scaled back conveyance improvements only version of the same.

Correspondences regarding as-builts for the redevelopment activities at 2139 White St and associated stormwater management plan.
