## **OLD BUSINESS:**

A. <u>T-872 PRELIMINARY/FINAL LAND DEVELOPMENT PLAN FOR PROPOSED</u> <u>RETAIL BUILDING AND DRIVE-THRU/FAST FOOD RESTAURANTS FOR</u> <u>WEST MANCHESTER TOWN CENTER</u>: This request was tabled from the March meeting. The applicant formally withdrew their plan, so this item is now closed.

#### **NEW BUSINESS:**

A. <u>T-877 FINAL LAND DEVELOPMENT PLAN FOR 1150 GREENWOOD ROAD</u>: Motion to approve the final land development plan depicting three (3) phases of a proposed building expansion for a loading dock, warehousing area, and dismantling area. The plan also depicts associated parking to improve business operations at 1150 Greenwood Road in the I-2 Light Industrial Zone. There is no additional sewage flows proposed as part of this plan. Johnston & Associates submitted a public improvements financial security estimate associated with this project in the amount of \$34,129.00. Eric Johnston spoke on behalf of Chuck's Auto Salvage, providing the Board with positive comments about the business and explaining further what they would like to accomplish. Matt from Chuck's Auto Salvage was also present. Vice-Chairman Ruman asked about storm water management for this plan. Mr. Johnston replied there will be an underground seepage pit, and that this was going above and beyond the requirements.

E. <u>FINAL COST APPROVAL OF PORTABLE RADIOS</u>: Motion to approve the purchase of 93 (ninety-three) portable radios for the police and fire departments. This was originally approved at the March Board meeting as an estimate. The official final price came in \$17,161.59 lower than estimated. The final cost to the County of York for the radios is \$238,826.25. Chairman Harlacher thanked Cliff and the fire department for finding an alternate solution by going in with the County to purchase these radios. Manager Kelch also mentioned that a grant was obtained to help with cost as well.
