V. UNFINISHED BUSINESS

A. <u>T-882 PRELIMINARY/FINAL SUBDIVISION & LAND DEVELOPMENT PLAN</u> <u>FOR MISTER CAR WASH #2516</u>: Motion to approve, revise, table or deny a preliminary/final subdivision and land development plan depicting the subdivision of a parcel from the parent tract and the land development of a drive-through car was facility located at 1410 Kenneth Road (1408 Kenneth Road)(Tax Map: 30; Parcel: 25) in the Highway Commercial Zone. The land development plan includes sewer planning module exemption mailer for 18,000 gallons per day which is equivalent to 52 EDUs to the Lincolnway Sewer System. The applicant also requests the Board accept the financial security estimate reviewed by Dawood in the amount of \$353,643.19. *This item was tabled at the March 28, 2024, meeting.*
