Analysis and correspondence on sewer capacity inquiry from Lawson's Mobile Home Community.

Attendance of quarterly meeting of Dover WWTP Advisory Committee.

Support for pumps station pump replacement including correspondence on whether a PADEP WQM Part 2 permit is needed for modernized pump replacements.
