SUBJECT: July 2025 Monthly Report

July was an extremely busy month with 120 calls for service. Within that our members responded to multiple working fires. As of this report, our members have responded to 34 working structure fires so far this year which is more than they responded to all of last year. I am extremely proud of the work the men and women do for the WMTFD. I continually get compliments from our neighboring departments of the work they do and how they enjoy having our members assisting them on their calls.

- There was a total of 707 personnel that responded to the incidents with an average of 7.9 per incident. (Average does not include Duty Officer & Fire Police Only Calls).
- Year to date, a total of 4,191 personnel responded to the incidents.
- We are at a 5.05% decrease in call volume from this time last year.

DEPARTMENT NEWS

- Back in May the board approved to purchase a new reporting software due to the current software being obsolete at the end of this year and will not meet the requirements of United States Fire Administrations new reporting requirements. We have officially started rolling out the software and are currently in the stages of configuring the software to meet the needs of our department as well as transferring the data from the current software to the new software. We hope to go live with portions of the software October 1st with a full live date of January 1, 2026.
- As reported at the beginning of my report I noted that we have had a large number of working structures fires. Just within the last month, the Township experienced 3 within the Township. While the men and women of the WMTFD did an excellent job with extinguishing the fires and saving as much property as they could there is one part that I am extremely upset with and that is the solicitation of Restoration Companies. More and more when a house fire breaks out within the county flocks of restoration companies are coming to the incidents soliciting business from the residents. On the three fires that the Township experienced over the past month, each time 3-4 restorations companies showed up uninvited soliciting to the residents for business. This is very disturbing that businesses are trying to gain business of our residents when they are in a vulnerable state and before they even have a chance to talk to their insurance companies. I reached out to Andy Herrold to see if this falls under our solicitation ordinance and it does. He has drafted letters that will be sent to each restoration company advising of our ordinance. A copy of the letter is included with this report.
