- There was a total of 613 personnel that responded to the incidents with an average of 9.73 per incident. (Average does not include Duty Officer & Fire Police Only Calls).
- Year to date, a total of 3,484 personnel responded to the incidents.
- We are at a 9.92% decrease in call volume from this time last year.
