As we start to move into the autumn and cooler months, we start thinking about turning on our furnaces, firing up our fireplaces, and looking for ways to keep our families warm. As such, it is also time to start thinking about fire safety.

Next month, is the 100th Anniversary of Fire Prevention Month. Fire prevention month was started because of the Great Chicago Fire that started in 1871 that took the lives of over 300 people. This year's theme is "Fire Won't Wait, Plan Your Escape!" The department has been diligently working with our daycares, pre-schools, and school district to provide fire safety presentations to all our young children and students. Currently we have 30 fire safety presentations on the calendar for the month of October. We look forward to another fun fire prevention month of teaching fire safety!!

Thank you to all our members who have helped put these presentations together and who has signed up to help teach these very important safety lessons.

TOWNSHIP EMERGENCY RESPONSES

- There was a total of 460 personnel that responded on the incidents with an average of 6 per incident. (Average does not include Duty Officer & Fire Police Only Calls).
- Year to date, a total 4,504 personnel responded on the incidents.
- We are at a 1.34% increase in call volume from last year.

DEPARTMENT NEWS

- The annual State Fire Commissioners Grant application period has opened. We once again applied for the maximum amount allowed of \$30,000. This year the grant was written for the purchase of new turnout gear for our firefighters. As our membership grows, we find ourselves having to outfit our firefighters with non-compliant turnout gear. Turnout gear becomes non-compliant once it reaches an age of older than 10 years. A new set (Coat, Pants, Helmet, & Boots) of turnout gear costs over \$4,000. This grant will allow us to purchase 7 sets of gear. As always, we will work with our vendor who will put our order together with multiple other departments ordering turnout gear to get us the best price.
- I recently met with Dr. Davies, the Superintendent of West York Schools to talk about offering Tax Credits to our Firefighters. He was excited about this opportunity and stated he really wants to do something for our volunteers. He and I will work together to talk to our school board about the importance of our volunteer's. During our meeting we also discussed about offering fire programs to our high school students. He was thrilled that the department wants to come into the High School and work with the students. We will be looking at different programs and curriculums to offer the students starting with the 2nd Semester of this school year or at the beginning of next school year. I will continue to keep the board updated on the progress of this exciting project.

• There were recently some sample ordinances released by the Pennsylvania Municipal League regarding fireworks based on the new fireworks laws. These were forwarded onto our Township Manager and Township Solicitor for review as we continue to look at updating fireworks ordinance.

During our August General Membership meeting we welcomed five (5) new members into the department.

We are super excited with the growth of our department. Several applications are on deck for our September meeting as well as several applications on deck for our October meeting. It is our hope and goal that we will hit 100 members by the end of the year.
