- A. <u>WEST MANCHESTER TOWNSHIP FIRE DEPARTMENT STRATEGIC PLAN</u>: Motion to approve, revise, table or deny the West Manchester Township Fire Department 2022-2026 Strategic Plan as presented by Chief Laughman at the June Board meeting. Copies of the plan were also given to the Board for review.
