#### **ZONING HEARING BOARD CASES**

<u>ZHB 24-01 – PermEx c/o Stephanie Rumer for Delco Plaza 1, LP –</u> requests a variance §150-283.B Permitted Permanent Sign Chart to modify the number and size of attached walls signs for an individual use within a shopping center (Giant) **located at 1255 Carlisle Road** (Tax Map: JH; Parcel: 0055B) in the Regional Commercial Zone.

Due to the inclement weather, the applicant was not able to attend tonight's meeting to present the variance request. Zoning Officer Sampere explained that there was a variance granted in 2006 which allowed the applicant to install seven (7) signs on the building façade totaling 222.50 square feet; however, there are currently six (6) signs installed on the building façade totaling 163.14 square feet. It is unclear why the applicant did not utilize the total number and area of allowable signs granted in the variance. Giant is rebranding and would like to remove the existing signs and replace them with four (4) signs on the building façade totaling 182.665 square feet. The proposed signs are as follows:

Giant at 67.08 square feet, Pharmacy at 22.83 square feet, Beer & Wine at 24.375 square feet, Giant Direct at 10.88 square feet. The Planning Commission discussed the request and agreed that reducing the number of existing attached signs from six (6) to four (4) and increasing the sign area from the existing 163.14 square feet to a total of 182.665 square feet is less than the original variance granted in 2006.
