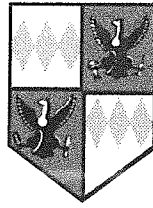

Police Chief's Report for June 2025

July 24th 2025

Dear Board of Supervisors, Manager and staff,

For the month of May, the officers handled 436 incidents as well as 65 vehicle crashes. Officers conducted over 402 traffic stops and issued 186 traffic citations. The department made 10 felony arrests, 15 misdemeanor arrests, 18 summary non-traffic arrests and 5 juvenile petitions were also filed.

The department handled among all the calls for service and other police related duties, The Rock the Country Concert event at the Fairgrounds. The event hosted approximately 25000 people per night. The personnel from the event worked with us on the security plan and Lt. Hanuska created the operations plan and the event was highly successful with very little problems. We staffed that event and coordinated the other security personnel.

The York Fair is starting this month, and we have been preparing and planning that event. This year we will be staffing the event with the help of several of our law enforcement partners, York County Sheriffs Office, York County Probation, Pennsylvania State Police, York County DA's Office and The York Fair Police.

Officer Andrew Shaffer graduated from the Police Academy on June 23rd. Myself and Lt. Emig attended the event at HACC. Shaffer is currently on field training and will be inserted into the patrol division once he is off of field training. It should be noted that


Shaffer won the physical fitness award while he attended the police academy. He received his diploma from his father who is a retired York City Police Officer.

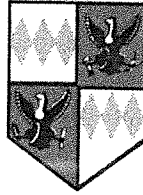

CI Division Report for July 2025 Board Meeting

6/19/2025 through 7/17/2025

Since June 19, 2025, WMTPD Criminal Investigations has taken on 9 new case assignments: 3 PICS cases, 3 theft/fraud investigations, a ChildLine Referral case for child endangerment, a found firearm, and a suspicious death investigation.

During the same time frame, our office has formally closed out 12 cases: 4 PICS cases (the 3 listed above and one from last month's report), a bad check case, 2 ChildLine Referral cases for suspected abuse/endangerment of children, an investigation into the possession of child sexual abuse material, a theft case, 2 investigations into illegal audio/video recording originating in January of this year, and the suspicious death listed above, which was ultimately ruled a suicide.

In addition to the above, Detectives were called upon from an off-duty status to assist with crime scene management and victim/witness interviews related to an arson case that involved aggressive behavior toward responding WMTFD firefighters and fighting/resistance directed at responding WMTPD officers, which resulted in a successful arrest.
