West Manchester 2035 is a 10-year plan for the Township's community and economic development. It's a plan for how land use, infrastructure, and community services should be aligned to accommodate growth and sustain quality of life in the Township. It's officially known as the comprehensive plan for its broad, integrated view of existing and future development in the community.

This short, 6-question survey asks: how long you've a citizen of the Township, what influences your choice to live, work, or own a business here, and your perspective on future development topics.

Response deadline is December 8, 2023. Submit your completed survey to Rachelle Sampere at the Township office. A public input summary will report common perspectives and be used to help shape the plan's goals and recommendations.

The Township will host another open house in Spring 2024 to present the preliminary recommendations for land use/zoning and other topics in advance of formal public review meetings. Stay tuned to Township news for the Spring 2024 open house date.
