#### MS4 MONTHLY REPORT - APRIL 2023

Inspection of 10 stormwater management facilities for new construction.

Update MS4 files for permitting.

Meet with numerous township residents to discuss why stormwater management is needed and their options to manage stormwater for their projects.

Perform follow up inspections for Stormwater Facilities with violations which had repairs made to them to bring them into compliance.

Resident called in to report a clogged inlet on Onyx Rd. Public works cleaned out leaves and debris from the inlet.

Meet with Wellington Greens Homeowners Association to look at stormwater issues. Existing Drainage swale became blocked, and water is rerouting into resident's yard. Public works investigated the issue due to it eroding near Township's interceptor. The township let Homeowners Association know it was their responsibility to maintain swale and fix erosion.

Public Works cleaned off inlet tops at Maple & Carlisle, Log Cabin & Carlisle, and at Loucks & Worth Roads.

Attend York County Stormwater Consortium Management Meeting at York Township.

Received complaint of stormwater runoff at Myers and Wolf Church Roads. I and Public Works investigated and found no issues.

Attend meeting at Center for Water Quality Excellence on HOA Stormwater BMP Management Workshop. Covered operations and Maintenance of BMPs.

Zeb Rauhauser, Dakota Joines, Michael Lutz, and Zane Williams attended Stormwater BMP Operation; Maintenance, & Inspection Training at York Co. Conservation District hosted by the York County Stormwater Consortium.

Township had Stormwater Seminar along with Manchester and Dover Townships at Dover Township on "A Homeowners Guide to Stormwater Management".
